- 3. Hon'ble members, GB also requested President GB to issue letter to the former Principal Sri D.K.Rout and Sri Rajendara Kumar Mohanty regarding their decision towards the protection of the College Land.
- **4.** That, the GB unanimously empowered the Principal-Cum-Secretary for filing of an appeal in the Apex Court against the judgment passed by the Humble High Court on dated 21.07.2023 vide RSA No-228/14
- 75. In this connection, G.B empowered the Principal-Cum-Secretary to submit papers, records and make affidavit as and when required by the Apex Court for the purpose.
 - **6.** That, the members present requested Hon'ble President GB to take necessary steps for the protection of the College Property.

ACTION TAKEN REPORT OF THE GOVERNING BODY MEETING HELD ON 31.07.2023

With Regard to the proceedings of the Governing Body meeting held on 31.07.2023 the following follow-up action/steps have been taken.

- 1. In pursuance of the resolution of Hon'ble GB, with regard to the judgement passed by the Hon'ble High Court of Odisha vide RSA No-228/14, dated -21.07.2023, regarding the land case against Salipur English Medium School, Hon'ble president GB and Principal-Cum-Secretary consulted with the legal experts and retired Judge for legal steps to be taken for protection of College property.
- 2. By of the resolution of Hon'ble Governing Body and as per the advice of the legal experts for protect of College land , an appeal was filled in Hon'ble Supreme Court of India against the judgement passed by Hon'ble High Court of Odisha vide RSA No-228/14 dated-21.07.2023 through Parekh & Co Advocate , Supreme Court of India.
- 3. In this Connection, necessary affidavit was made and related papers, records along with documents were submitted in the Supreme Court as per the requirement.
- 4. The Case was listed vide Case No-SLP(C)25673- SALIPUR AUTONOMOUS COLLEGE, SALIPUR VS SLIPUR ENGLSIH MEDIUM SCHOOL and ORS on 04.12.2023 in Court No-11 as Item No-06 in SUPREME COURT OF INDIA before Justice J.K Moheswari and Justice K.V.Vishwanathan..
- 5. Again the above mentioned matter was listed on 05.03.2024 in Court No-10 as Item No-10 Subject to order for the day –SUPREME COURT OF INDIA.
- 6. Further the petition for Special Leave to Appeal(c) No-25673/2023 was listed on 07.03.2024 in Court No-11 as Item No-40 subject to order for the day-SUPERME COURT OF INDIA before Justice J.K. Maheswari and Justice Sudhanshu Dhulia . The Case was admitted and upon hearing the counsel the Court made the following ORDER "Issue notice, returnable in Six Weeks".
